GENERAL INFORMATION

The Scotstown Medical Group has been at the forefront of developing and piloting new models of care in conjunction with NHS Grampian, and actively encourages staff development and education. This has been especially evident as we have developed systems to support GPs through PAs, ANPs, and pharmacists working to deliver safe effective care, including triage and home visits. We also encourage our GPs to develop their own specialist areas that are of interest to them. The practice uses the Vision clinical system, with document management via Docman and digital dictation through Lexacom. Planned development here includes the introduction of the Docman Intellisense module as we approach the move to a cloud-based hosted version of Vision.

Scotstown Medical Group is an equal opportunity employer, accredited with the Real Living Wage Foundation, and a licensed visa sponsor with the UK Home Office. We are committed to teamwork and high quality patient care, as well as the development and support of all our staff. In Dyce we are situated in a purpose built health centre adjacent to Dyce Academy and the Asda retail park, while at Bridge of Don we have our own purpose built premises in the heart of our community. Both have good transport links and road access with the opening of the new AWPR.
